Location

The property is conveniently located on Plumber's Row at it's junction with Coke Street, within walking distance to both Aldgate East and Whitechapel Stations, and furthermore less than a mile from Spitalfields, Shoreditch and the City. Commercial Road (A13) is situated to the South of the demise and Whitechapel Road (A11) directly to the North. On-street regulated parking is available in the immediate vicinity.
